Asian Development Bank (ADB)	African Development Bank (AfDB)
ADB Education and Training Project	Livestock Development Project in São Tomé and Príncipe
This project enables ICDF personnel to gain project management skills and experience from the ADB, and to encourage further bilateral cooperation. Each year, the ICDF recommends one staff member for a six-month internship in the ADB's project department.	In accordance with the Livestock Development Project implemented by ICDF Technical Mission, the AfDB provides loans to help establish livestock infrastructure.
Third Urban Water-Supply Project in Papua New Guinea	Two International Roads Project in Swaziland
This project is developing the water supply and sanitation in urban areas and consists of three parts. The ICDF is involved in Parts A and C and the Asian Development Bank in Parts B and C.	This project will upgrade two roads in Swaziland, improving tourism and helping develop the nation's agricultural sector. The AfDB, the ICDF, and the Kingdom of Swaziland provided the funding of the project.

Nicaragua Rice and Vegetable Training Class	Belize Tourism Development Project
Cooperating with the ICDF Technical Mission, both organization work together to provide agricultural training for Nicaraguan farmers.	This project is assisting the Government of Belize in developing and conserving important Mayan civilization archeological sites.
Central American Trade Promotion Seminar	Southern Highway Rehabilitation Project
The ICDF works closely with CABEI to invite scholars and specialists from both Taiwan and Central American countries to discuss in trade related issues and trends.	The ICDF and the IDB are cofinancing this highway project. The ICDF funded Section IV and the IDB funded Section V.
SME Advisory Projects in Central America	Aquatic Products Processing Assistance Project in Nicaragua
Along with the ICDF Technical Assistance Projects, CABEI and the ICDF provides financial assistance to cooperating countries for purchasing vocational equipment and for conducting specialized training.	The ICDF is sending specialists to help Nicaragua in the promotion of the aquatic product processing industry. Also, the ICDF has provided vocational training courses to cultivate seed teachers in Nicaragua for future industry development.
Credit Guarantee Projects in Central American Countries	Program for Modernizing the National Congress and the Office of the Comptroller General, Dominican Republic
The ICDF provides credit guarantee services for Taiwanese companies that would like to invest in the region through 30 financial institutions that have cooperating relationships with CABEI.	This project is modernizing the Dominican Republic National Congress and the Office of the Comptroller General, strengthening their legislative and oversight functions. The long term goal is to strengthen democratic governance in the Dominican Republic. The project is cofinanced by the IDB, the ICDF and the Government of Dominican Republic.
European Bank for Reconstruction and Development (EBRD)	Program for Environmental Pollution Control in Critical Areas of El Salvador
SME Relending Project in Belarus	This project is establishing environmental management systems in three critical areas: air quality management, water quality management and integrated management of solid waste. The government of the Republic of El Salvador, the ICDF and IDB cofinanced the project.
This project is solving capital shortage problems for SMEs in Belarus, improving industry competitiveness, and boosting the Belorussian economy.

Internet Education Development Project	Investment and Lending Project to the Micro-Credit National S.A. in Haiti
The ICDF is cooperating with World Links in funding and support for use of the Internet in secondary education in Allied nations. More than 32,000 students are benefiting from this project. Housing Solidarity Reconstruction Program in Honduras	This project is enhancing the private sector development in Central and Eastern Europe. With the contribution of US\$12.5 million into the "Financial Intermediary Investment Special Fund", the ICDF is engaging in various investment ventures with the EBRD in Eastern Europe and Central Asia.
