2.1 How technological tools can be incorporated into the formulation of public and private sector development strategies to enhance the women’s participation and empowerment.

2.2 How public-private partnerships can integrate technology with social innovation to enhance women’s rights in tangible ways.

A discussion of how the Ministry of Education in Taiwan leverages mechanisms such as industry-university matchmaking, establishment of innovative entrepreneurship platforms, and creating industry-business networking platforms to develop technical and vocational education responsive to changes in industry and demand for talent in society, as well as enhancing youth employability; government representatives from Latin American and Caribbean allies are also invited to share their national policies and resources on boosting women's right to education and occupational training for women.

#### Discussion Focus 2: Case Studies in Women's Micro-Enterprises.

"Swing Reeds" will be used as an example to showcase Taiwan's results and experience in supporting economic independence and social participation of middle-aged and elderly women through micro-enterprises. Graduates of the TaiwanICDF "Assisting Economic Empowerment of Women in Latin America and the Caribbean in the Post-Pandemic of COVID-19 Project – Vocational Training" will also be invited to share micro-enterprise outcomes.

#### Discussion Focus 3: Provision of Technical and Vocational Training by TaiwanICDF to Develop Women's Professional and Entrepreneurship Skills.

TaiwanICDF offers intensive, short-term, themed entrepreneur training courses to provide women micro-entrepreneurs with the knowledge they need at different stages, and start-up grants to help Latin American and Caribbean women achieve economic independence.

Women are a force contributing to stability and resilience in the course of economic development worldwide. Closing the gender gap in economic participation is critical to boosting economic recovery from the COVID-19 pandemic and achieving inclusive growth. However, women face significantly greater challenges than men in obtaining access to affordable financial services. This is the biggest barrier for them to participating in economic activities and improving their lives.

This forum will explore and discuss how to support women in realizing economic empowerment through financial inclusion.

**Topic 1:** Challenges women face in accessing affordable financial services.

**Topic 2:** Government strategies and policies to enable women's access to financial services.

At the forum, governmental officials from Taiwan and Latin America and the Caribbean (LAC) will share the current development status of women entrepreneurship in their countries and relevant policies and measures to enhance women's access to financial services.

**Topic 3:** Development organizations' strategies and actions to increase women's access to finance.

TaiwanICDF and regional development organizations in the LAC region will share their strategies and projects to improve access to finance for women. Women entrepreneurs benefitting from TaiwanICDF's support will share their stories and experiences.

**Topic 4:** Approaches and practices taken by financial institutions to promoting financial inclusion.

**Topic 5:** Harmonizing local, bilateral and multilateral resources for a greater synergy for empowering women through finance.
