**Background**

The World Economic Forum's Global Risks Report 2022 found that environmental risks are perceived to be the most critical long-term threats to the world, as well as potentially the most damaging to people, especially in developing countries. In recent years, Science, Technology and Innovation (STI) provide a path forward for reconciling environmental and developmental needs by combining innovative scientific and technological breakthroughs with social and economic actions.

Furthermore, STI applications play an essential role in preparing for crises, building resilience and aiding disaster adaptation management. They are also key enablers of environmental sustainability transitions in systems like energy, food and biodiversity, and, as a result, STI initiatives are key to accomplishing the Sustainable Development Goals (SDGs).

Moving forward, international cooperation on STI research and applications in SDGs will be crucial. Israel and Taiwan have much in common, including their abundance of human capital and laudable successes in STI sectors. Based on their countries' robust bilateral relations, MASHAV and TaiwanICDF held a working meeting in June of 2022. In the following August, SID Israel, joined a second meeting in a trilateral partnership. Based on the discussions, these three organizations decided to hold cross-sectorial partnership knowledge-sharing webinars on shared core interests. We hope that these events later evolve into a more concrete collaboration between MASHAV and the TaiwanICDF through SID Israel.

## **Organization of the Webinar**

This webinar invites representatives from international development agencies and private sectors to share information and tool tips on the latest STI developments. Representatives from international development agencies will introduce methods for mobilizing STI resources to expand aid efficiency and create a more efficient, resilient and sustainable world. Representatives from private sectors will share methods for connecting the public and private sectors through existing timely, accurate and affordable STI, which can be utilized in the fields of environmental sustainability and disaster management. Furthermore, participants can exchange views on achievements, challenges and cooperation opportunities during discussion sessions.

## **Objectives**

This webinar aims to provide a platform for like-minded partners to develop an understanding of STI technologies and their applications. Participants shall learn methods for achieving sustainable transformation by mobilizing STI for faster responses and better resilience, all to improve environmental sustainability and disaster management in target areas. Moreover, the webinar will explore innovative ideas for participants operating at the cross-sector of ODA and STI, helping them scale up aid efficiency and reinforce their public-private partnerships. We also welcome all participants to share their efforts and challenges in leveraging STI applications, as these discussions will lead to new solutions and cooperation opportunities for aiding in countries' development.
