

Core Strategies

Uphold the TaiwanICDF's vision, emphasize substantive results in our assistance work and strengthen the integration of public and private sector resources, as well as the variety of cooperative partnerships we engage in.



Sources of Funding

The TaiwanICDF was established with an initial endowment of NT\$11.6 billion, which was the net value of the IECDF's funds at the time of its dissolution. Sources of funding include the general fund, interest, returns on investments and income from commissions by the government or other institutions. As of December 31, 2013, the total balance of all funds was NT\$15.74 billion.
