

JOB DESCRIPTION



I. POSITION PURPOSE/JOB MISSION

Provide technical expertise in the area of health and nutrition that will contribute for the improved performance and timely delivery of Integrated Action for Children's Nutrition (INTERACTION) Project based on the Detailed Implementation Plan.

II. **POSITION GOALS AND OBJECTIVES** (Generic Performance Measures)

Provide expertise and support to the Operations Division specifically in the implementation of INTERACTION Project in selected pilot sites of the Leyte-Samar Cluster of Field Office Visayas.

III. MAJOR RESPONSIBILITIES (BASED ON GOALS AND OBJECTIVES)

- A. Assists the project staff on operational management specifically in the implementation of project activities.
- B. Assists in the organizing, capacity building, and monitoring of organized groups (health workers and breastfeeding support groups) to educate care givers on proper feeding practices.

- C. Provides technical assistance in ensuring visibility and/or proper branding of the project e.g. logo, designs, Information, Education and Communication (IEC) materials and other relevant brand placements based from the standard of TaiwanICDF.
- D. Provides technical support in carrying out monitoring to ensure the progress of rehabilitating malnourished children.
- E. Assists in the implementation of project activities specifically in rolling out Infant and Young Child Feeding (IYCF), Positive Deviance and Hearth (PDH), proper feeding, hygiene and sanitation practices.
- F. Engages with and learns from external and internal stakeholders in the design, monitoring and implementation of the project.

The following competency may be acquired through a combination of personal commitment, formal schooling, education, prior experience:

- A. **EDUCATION:** With Bachelor's degree preferably in Health and Nutrition or other health and allied health related courses with focus on Maternal, Newborn Child Health and Nutrition (MNCHN).
- B. **EXPERIENCE:** At least 2 years of broad and deep experience in providing technical expertise in Health and Nutrition and MNCHN.
- C. **EXPERTISE:** Expertise in IYCF, Nutrition and other Maternal and Children Health concerns.
- D. **COMMUNICATION:** Can understand and speak English and ability to work in an international and local context.
