# Introduction

# ■History of the TaiwanICDF

Taiwan's economic development was greatly facilitated in its early stages by development assistance from other countries and political democratization was also enhanced with overseas support. Therefore, Taiwan has a continuing responsibility to return this generosity to international society by assisting other countries in their own economic and social development.

In 1961, under "Operation Vanguard," special agricultural technical missions helped improve fruit and vegetable production in many newly independent African countries. In 1962, these missions were expanded to become the "ROC-Africa Technical Cooperation Committee," which merged with the Committee of International Technical Cooperation (CITC) in 1972.

Simultaneously, Taiwan was developing one of Asia's most dynamic economies. In the hope of sharing Taiwan's prosperity and economic experience with the rest of the world, the International Economic Cooperation Development Fund (IECDF) was established in October 1989 under the supervision of the Ministry of Economic Affairs. Soon thereafter, the IECDF was given the responsibility for providing various types of economic and social assistance to developing diplomatic allies and friendly nations. As the variety of cooperative development projects expanded yet further, and the number of overseas technical missions increased, Taiwan's government consolidated the CITC and the IECDF into an independent organization in 1996 and 1997: the International Cooperation and Development Fund (TaiwanICDF).

The TaiwanICDF's core work programs include banking and finance operations, technical cooperation, international human resource development and humanitarian assistance. The Fund has put together a wide array of international cooperation programs designed to help diplomatic allies and friendly nations develop their economic and social sectors, reduce poverty, strengthen human resources development, expand agricultural productivity and rebuild after natural disasters. Since its establishment, the TaiwanICDF has also established and strengthened cooperative relationships with numerous international organizations, regional agencies and NGOs.

Taiwan's civil society is energetic and talented with tremendous resources that can be tapped into in conducting international cooperation. The TaiwanICDF established the Overseas Volunteers Program in 1996. Since 2001, qualified young men could assist in international development through the Taiwan Youth Overseas Service. Both programs are strengthening assistance activities through cooperation at the grassroots level. All undertakings that can contribute to improving the cooperating country's economic and social development are within the scope of both programs.

# The Joint Board of Directors and Supervisors and the Consultative Committee

# ■ Joint Board of Directors and Supervisors

The statutes of the TaiwanICDF provide for a Board of Directors of eleven to fifteen persons and a Board of Supervisors of three to five members. The Executive Yuan appoints these Board members. The Board of Directors consists of senior government ministers, heads of other government agencies, distinguished scholars, and leading industrialists. One third of the Board must come from the latter two categories.

The duties of the Board of Directors include shaping policy, approving specific projects and lending operations, overseeing annual budget allocations, appointing and dismissing senior management, and attending to all other important affairs.

#### **■**Consultative Committee

# **Organizational Framework**

The TaiwanICDF is led by its Secretary General, and supported by the Deputy and Assistant Secretaries General. The Fund has five departments and four offices. As of December 31, 2005, the TaiwanICDF had a staff of 76 full-time members, 249 technical experts, 83 Taiwan Overseas Volunteers, and 107 Taiwan Youth Overseas Service members.

- Manages the TaiwanICDF Web site

#### **Banking and Finance Department**

- Provides financing and investment for economic development projects
- Oversees credit guarantee operations
- Manages the financial affairs of the TaiwanICDF
- Supervises cofinancing with international organizations

#### **Technical Cooperation Department**

- Plans and manages overseas technical mission projects

#### **International Human Resource Development Department**

- · Acts upon key resolutions adopted by the Board of Directors or matters entrusted by the Secretary General
- Conducts special inquiries on and follows the progress of key activities as well as project implementation procedures
- Investigates and analyzes the causes and proposes solutions in problematic cases

- Compiles and is responsible for annual budgets and year end finanical statement
- Pursues the execution of the budget
- Manages monthly financial reports and accounting affairs
