# **Appendix I: Meetings of the Board of Directors and Supervisors**

# **Thirteenth Meeting: 4 October 1999**

The board agreed to process loan guarantees for ROC industry investments with its allies. It also approved the Environmental Pollution Control Project in Critical Areas in El Salvador, a cooperative lending project with the Inter-American Development Bank (IDB).

# Fourteenth Meeting: 18 January 2000

The board discussed ICDF appropriations for a special cases fund of under US\$2 million, in order to execute a small investment SME project in Macedonia. The Ministry of Foreign Affairs agreed to appropriate a budget for general use in this project; approved a loan of US\$8 million for technical education and vocational training in El Salvador; and provided US\$1 million, to be used over three years, for the Global Network for Educational Development project.

#### Fifteenth Meeting: 20 April 2000

The board agreed to provide US\$12 million for the Skopje Free Economic Zone development project in Macedonia. It also approved the request to extend the scope of the agricultural loan special case project in order to include investment projects for microenterprises, SMEs and agricultural industries.

### Sixteenth Meeting: 2 August 2000

The board approved the intermediate phase of the ICDF's current foreign assistance strategy, the core projects from 2001 to 2003 and the budget for 2001. It also confirmed the appointment of Dr. Yang Tzu-pao as the Deputy Secretary General of the ICDF for a three-year term (from 16 August 2000 to 15 August 2003).

# **Seventeenth Meeting: 18 December 2000**

The board approved the project covering the modernization of the National Congress in the Dominican Republic—a cooperative lending agreement with the IDB—and requested that the ICDF enhance its control and oversight of the project. It also requested that the ICDF confirm budget details of this project with the IDB, inform the ROC embassy in the Dominican Republic of project details, and provide related data to Taiwanese industry seeking commercial opportunities in the Dominican Republic. It also approved the Belize Tourism Development Project, which is cosponsored by the IDB, and requested that the ICDF provide relevant information to the ROC embassy in Belize.
